**Invitation to Bid for**  
**COMPLETION OF VETERINARY MEDICINE HOSPITAL**  
**(GF-PB-19-018)**

1. The Central Mindanao University, through the *GENERAL FUND* intends to apply the sum of ***Nine Million Nine Hundred Ninety-Nine Thousand Nine Hundred Ninety-Six Pesos and Eighty-Two Centavos Only (9,999,996.82)*** for **COMPLETION OF VETERINARY MEDICINE HOSPITAL**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Central Mindanao University now invites bids for **COMPLETION OF VETERINARY MEDICINE HOSPITAL**. Completion of the Works is required Three Hundred Sixteen (316) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Central Mindanao University and inspect the Bidding Documents at the address given below from 7-11 a.m. – 1-5 p.m.
5. A complete set of Bidding Documents may be acquired by interested bidders on *April 30, 2019 to May 20, 2019* from the address below upon payment of a nonrefundable fee for the Bidding Documents, in the amount of *Ten Thousand Pesos Only (10,000.00)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.


6. The Central Mindanao University will hold a Pre-Bid Conference on May 8, 2019 @ 10:00 am at BAC Office, CMU, Musuan, Bukidnon, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before *April 30, 2019 to May 20, 2019*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 0**.

Bid opening shall be on *May 20, 2019 at 10:00 am* at *BAC Office Conference Room, Musuan, Maramag, Bukidnon*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. All envelopes shall be properly labeled and provided with Ear tags/Index tabs for every document submitted in the Bid documents. Representative shall always present a written authority (SPA) from the licensee/proprietor and all documents submitted shall be in the Standard forms.
9. The *Central Mindanao University* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
