


Your failure to comply these requirements shall constitute a sufficient ground for the cancellation of this award and the forfeiture of your Bid Security.

CONTRACT OF AGREEMENT
(21-03-INFRA)

This AGREEMENT entered into at Musuan, Maramag, Bukidnon by and between the Republic of the Philippines, through the *Central Mindanao University* represented by **DR. JESUS ANTONIO G. DERIJE** in her capacity as *University President*, hereinafter referred to as **PARTY OF THE FIRST PART**.

And

ERIANE CONSTRUCTION & SUPPLY of G. Lavina Ave., Poblacion, Valencia City, represented **ENGR. ERIC A. CUPIDA** in his capacity as Proprietor/Manager hereinafter referred to as **PARTY OF THE SECOND PART**.

WITNESSETH

WHEREAS, the PROCURING ENTITY is desirous that the CONTRACTOR execute the works under General Funds- **PROPOSED CONSTRUCTION OF VIRTUAL NURSING ARTS BUILDING**, hereinafter called "the works", and the PROCURING ENTITY has accepted the calculated Bid of the CONTRACTOR for the execution and completion of the Works within One Hundred Thirty Six (136) calendar days at the calculated unit bid prices shown in the following Bill of Quantities, or a total Contract price of **Ten Million Three Thousand Three Hundred Seven Pesos and 96/100 Pesos (Php10,003,307.96)**.






